



Dear California ABC Licensee:

Enclosed are California Proposition 65 BPA Warning Signs. You are receiving these signs because effective May 11, 2015, the Office of Environmental Health Hazard Assessment (OEHHA) added *bisphenol A (BPA)* (CAS No. 80-05-7) to the list of chemicals known to the state to cause reproductive toxicity for purposes of the Safe Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65).

On the reverse side of this letter is a copy of a point of sale and a point of display warning sign for BPA. You may photocopy these signs so that you have enough for your own needs. The point of sale sign reads:

**WARNING:** Many food and beverage cans have linings containing bisphenol A (BPA), a chemical known to the State of California to cause harm to the female reproductive system. Jar lids and bottle caps may also contain BPA. You can be exposed to BPA when you consume foods or beverages packaged in these containers. The point of display sign reads:
